2022 CAT LICENSE

WE WISH TO ADVISE THAT RENEWAL OF YOUR CAT'S LICENSE FOR 2022 IS DUE AND THIS WILL BE YOUR ONLY NOTICE.

THE REVISED HEALTH CODE OF THE BOROUGH OF CLOSTER, CHAPTER 250-26A, STATES:

- (1) ALL CATS OVER FOUR(4) MONTHS OF AGE MUST BE LICENSED
- (2) THE LICENSE IS GOOD FOR ONE YEAR, RENEWED BY JULY 31
- (3) THE IMMUNITY AGAINST RABIES SHALL BE FOR THE DURATION OF THE LICENSING PERIOD
- (4) THE LICENSING FEE IS \$11.20 FOR EACH SPAYED/NEUTERED CAT AND \$14.20 FOR EACH NON-NEUTERED/SPAYEDCAT.

MAKE CHECKS PAYABLE TO BOROUGH OF CLOSTER

IF YOUR CAT'S RABIES VACCINATION EXPIRES PRIOR TO JULY 1, 2022, YOUR PETMUST BERE-VACCINATED BEFORE A LICENSE CAN BE ISSUED. IF YOUR CAT RECEIVED A RABIES VACCINATION AFTER THE LAST LICENSING PERIOD.

PLEASE SEND US PROOF OF RABIES VACCINATION AND NEUTERED/SPAYED.

YOU MAY OBTAIN A LICENSE BY COMPLETING THIS FORM AND RETURNING IT TO THE CLOSTER HEALTH DEPARTMENT, 295 CLOSTER DOCK ROAD WITH YOUR CHECK OR MONEY ORDER.
