a. <u>MAIL LIST OF NOVEMBER 12, 2015</u> – Mayor Glidden asked if any member of the Council wished to address any matter or provide any comments. Item No. 3a was removed by Councilwoman Latner; Item No. 9 was removed by Mayor Glidden.

<u>Item No. 3a:</u> Received 11/10/15, dated 11/10/15 from Michael J. Darcy, CAE, Executive Director, NJS League of Municipalities re Daily Update re: Governor Christie Takes Action on Various Bills of Interest (Copy to Chief Kaine, Jim Oettinger, Chief Pierro)

Councilwoman Latner referred to the following: "P.L. 2015, c. 143, establishes an additional category of State school aid known as commercial valuation stabilization aid. A school district may receive this aid upon the recommendation of the Commissioner of Education, if it is situated in a municipality in which: 1) commercial property accounted for at least 75 percent of the total assessed property valuation in 2008, and 2) between 2008 and 2013, the assessed value of commercial property declined by at least 25 percent. The law took effect on November 9, 2015." She said she has no idea and wondered if it would be worthwhile to look into those years in terms of the decline in value where we could get more State aid. Mayor Glidden asked if the Borough Attorney had anything to add to which Mr. Rogan informed he did not. The Mayor asked Councilwoman Latner to look into this further and said he would get a contact at the DOT for her to start with.

Councilman Barad referred to the following: "P.L. 2015, c. 122, which requires municipalities that license peddlers and solicitors to accept certain background check results from other municipalities, will take effect on March 1, 2016" and noted he wanted all to be aware of same. Chief Kaine responded that the Borough does their own anyway. In response to Councilman Barad, Borough Attorney explained we would have to accept it but he does not think it would stop us from updating the provided background check depending on when it was done. He informed he would look further into same and report back.

Regarding the Library, the Stop and Shop at their ribbon cutting ceremony had presented them with a \$2,000 check; and an article on same appears in today's paper. She said what is impressive is that Stop and Shop partners with a non-profit in their community and the Library will be exclusively using these funds for children's services. The other thing she wished to note was that they do a lot of outreach and they are also working with the Closter Food Pantry. Mrs. Latner informed she had received and passed on information to the local and regional school regarding Stop and Shop's A+ School Rewards programs. She said if the schools sign up for this and then people can sign up for any of those schools and a percentage of their purchase will be given to that school. The Library had a music program on the 13th and it was standing room only; and the ESL instructor is working to help people improve their language skills. In terms of the High School, there is another meeting tonight that she is unable to attend but she reminded that they had discussed everything the architect wanted to do in terms of the STEM rooms for the Referendum; and there had been a question and answer session because it seemed pricey. The bottom line is that the contracts will be subject to public bidding laws and a lot of the things they are including are very old and out of date and need to be replaced. The President of the Board of Education admitted it was unlikely at this point that the Referendum will be held in January 2016 so they are considering September and November 2016. Mrs. Latner reiterated some of the great programs and accomplishments going on at the Regional school.

7. <u>OLD BUSINESS</u>

Borough Administrator noted that he has met with Orange and Rockland regarding the placement of the utility pole at 39 Julia Street and the homeowner and neighbor are in agreement. A resolution authorizing same, per Borough Code, has been approved by the Borough Attorney for the next meeting. At the next meeting he will have a new 457 Plan provided by Lincoln Financial, our current provider; but they will give more options to the Borough employees as far as fund options. He will be requesting approval for the Mayor to sign renewal of the Dental Plan through Horizon that is necessary on December 1, 2015. A resolution would be provided at the meeting of December 9, 2015. He said that he has reviewed a Day Care Savings Plan at Lightbridge Academy at no cost to the Borough to join but would provide a 10% discount for employees and volunteers. He would provide a resolution for approval at the next meeting for the Mayor to sign this agreement. A vacation day carry over for the employees has been extended for the first quarter. A resolution will be provided for the next meeting.

8. <u>NEW BUSINESS</u>

Borough Attorney noted that last year a vendor sold Christmas trees at the Closter Commons parking lot. Mr. Watkins has sent a letter objecting to same this year and Mr. Montroy sent a letter that approval of this item should be addressed by the Mayor and Council. The item could be addressed under the Peddlers and Hawkers section of the code, which would require a permit fee in addition to Mayor and Council approval. There would be conditions relative to dates and times of the sale and a possible permit fee. Councilman Barad noted that Mr. Watkins states that Closter Commons is in the business zone, which does not allow outdoor storage or sales of any items. Borough Attorney said that these types of sales can be approved by the Mayor and Council.

Ron Miller, 192 East Linden Avenue, Englewood, said he checked with the Borough last year relative to the sale of Christmas trees and found that there is no ordinance prohibiting this activity. We conducted business there last year and he has a signed lease with President of Closter

Commons. He is insured for liability and has experience in selling Christmas trees. He brings diversity for seasonal sales, during which they play Christmas music. He said he is agreeable to any requirements of the Mayor and Council. In answer to Mayor Glidden, Mr. Miller said that the hours of sale would be 12 p.m. to 8:30 p.m. and the start day would be the day after Thanksgiving until a day or two before Christmas. Last year we did a proper clean up of the area of the sale which encompasses approximately 10 parking spaces at the northeast corner of the parking lot at Homans Avenue and Piermont Road. Flow of traffic is not obstructed. He said he has 40 years experience selling Christmas trees and in Englewood we rent from the Borough and donate to the Food Bank. All of the employees are residents of Closter or Demarest who are athletes who attend or have attended the High School. Mayor Glidden attested to his having a good business and said that a resolution would be addressed in the Regular Meeting.

Steve Isaacson, 97 Columbus Avenue, noted that a privately owned farmers market operated in Closter Commons for a year in addition to the St. Mary's parking lot and Borough Attorney said the Mayor and Council had approved same. Relative to the School Referendum, Mr. Isaacson said urged the Council to dissuade the Board from changing the date to anything but November because of the Presidential Election. The Presidential Election will bring out a high voter turn out and the referendum should be held when most people are around. He referred to the Land Use Meeting on Saturday, which he felt was not well publicized and there was too much time in between meetings. There should be Community Forums. Financial incentives should be offered to the downtown landlords to effect change. He also said that people should be encouraged to volunteer and recognized for same. He said he has never been recognized as a member of the Environmental Commission nor for the good work he has done. Mayor Glidden referred to a memo he sent out after the meeting and noted that there were 14 action items, most of which refer to the downtown and he agreed that more meetings should be held.
