b. <u>ORDINANCE NO. 2017:1231</u>, "AN ORDINANCE OF THE BOROUGH OF CLOSTER ADOPTING REGULATIONS RESTRICTING THE PLANTING, GROWING OR CULTIVATING OF BAMBOO"

Mayor Glidden opened the meeting to the public.

Steve Isaacson, 97 Columbus Avenue, noted that he and several of his neighbors have had bamboo on their properties for over 20 years and his new neighbor has indicated that he loves the bamboo and cannot imagine living without it. Two neighbors on Durie Avenue had their bamboo removed and he had part of his bamboo removed and part of it contained. This year he had all of his bamboo except one section removed at a cost of \$20,000. He cited the section of the ordinance dealing with the planting and location of bamboo, which shall be no closer than 10 feet from the property line. He said that this would mean his one section of bamboo would have to be removed. Borough Attorney cited Section 3 of the ordinance, which provided an exception to the ordinance to property owners with existing bamboo. Mr. Isaacson said it is an undue hardship to be a good neighbor and he asked that the ordinance be reviewed. He appreciated that his bamboo has been grandfathered.

Councilman Barad noted that it is not be intent of the Council to burden property owners and the Borough Attorney has clarified the wording of the ordinance. Mr. Isaacson expressed the agreement that bamboo is an invasive plant. Borough Attorney noted that if the Chief of Police or Construction Code Official makes a finding, there must still be a burden of proof; and if it encroaches on a neighbor's property, it can be trimmed back.

No one else wishing to be heard, Mayor Glidden closed the public hearing.

27. <u>ANY OTHER MATTER WHICH MAY COME BEFORE THE GOVERNING BODY</u>

Councilwoman Amitai questioned if there should be one person or two for Construction Official and Zoning Officer positions and she felt there should be two persons so as to provide coverage for residents during vacations or illness. She did not have the figures with her but the research indicates that the money is the same whether there is one person or two since we are now paying more for one than we were paying for two a year ago. The zoning officer signs off on applications that come into the Building Department and the Construction Official signs off on the Certificate of Occupancy thereby providing checks and balances for each application. Two people would also eliminate incorrect interpretations of the Borough Code. Councilman Barad said that at the time of the Zoning Officer's retirement, it was felt that having one person would be temporary and historically we have favored having two people. The matter should be reviewed and the oversight issue and cost discussed. Mayor Glidden noted that it is a reasonable assumption to have two people rather than one; and he requested that the cost breakdown be circulated to the Council for discussion at the next meeting. Borough Attorney said that decision should be made by the Reorganization Meeting in 2018. Discussion on whether there should be one person or two persons is acceptable but talking to the Construction Official on the term is getting close to a discussion on job status.

WHEREAS, the Borough of Closter has a constitutional obligation to provide for affordable Housing; and

WHEREAS, the Governing Body may, pursuant to N.J.S.A. 40:12-4, acquire real property for a public purpose; and

WHEREAS, the Borough of Closter desires to acquire certain property for its Affordable Housing needs and for a public use and said property is commonly known as "Village School" located at 511 Durie Avenue in the Borough of Closter; and

WHEREAS, said property is also known as Block 1316, Lot 9 on the Tax Map of the Borough of Closter; and

WHEREAS, the Governing Body has determined that this acquisition at a purchase price in the amount of \$3,550,000 is in the best interest of the Borough; and

WHEREAS, a portion of said purchase price will be paid with funds provided by the Affordable Housing Trust monies in the amount of \$900,000; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Closter, County of Bergen and State of New Jersey as follows that the property known as 511 Durie Avenue "Village School" in the Borough of Closter be acquired for public use by the Borough for the purchase price in the amount of \$3,550,000.00; the Borough Attorney is hereby authorized to prepare all necessary documentation for the purchase, make application to the Affordable Housing Judge assigned to the matter captioned "In the Matter of the Application of the Borough of Closter" Docket No. BER-L-6372-15 for release of \$900,000 of the Closter Affordable Housing Trust monies. The Mayor and Clerk are hereby authorized to execute the contracts and other documents necessary pursuant to the purchase.

BOROUGH OF CLOSTER ORDINANCE NO. 2017:1231 AN ORDINANCE OF THE BOROUGH OF CLOSTER ADOPTING REGULATIONS RESTRICTING THE PLANTING, GROWING OR CULTIVATING OF BAMBOO

WHEREAS, concerns have been raised by residents about the excessive and uncontrolled growth of bamboo in the Borough of Closter, and its impact on both Borough property and private property; and

WHEREAS, the Ordinance and Legislative Committee has discussed adoption of this Ordinance and recommends same to the Governing Body; and

WHEREAS, the Borough Attorney has reviewed this Ordinance and deemed it in order; and

WHEREAS, the Governing Body has determined that this Ordinance is necessary and in the best interest of the Borough;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Closter, County of Bergen and State of New Jersey, as follows:

SECTION 1 Purpose.

This Ordinance is adopted to control the planting, cultivating or growing of bamboo in the Borough of Closter, and to require barriers to prevent the spread of existing bamboo into other areas of the Borough.

SECTION 2 Regulation of planting, growing or cultivating of bamboo.

Subject to certain exemptions set forth in this Ordinance, no persons, or other property owners or tenants, shall plant, cultivate, or cause to grow any bamboo on any lot or parcel of ground in the Borough of Closter, subject to the following exceptions:

- A. The root system of such bamboo plants is entirely contained within an aboveground-level planter, barrel, or other vessel of such design, material, and location as to entirely prevent the spread of growth of the bamboo plants' root system beyond the container in which it is planted; or
- B. The root system is contained within a properly constructed and maintained barrier system.
- C. Whether planted or growing in a container, as described herein, all bamboo plants shall be located, trimmed and maintained so that no part of the plant shall be closer than 10 feet from any property line or right of way.

SECTION 3 Exemptions.

This Ordinance shall not apply to any land owner or possessor who, prior to the effective date of this Ordinance, has planted or caused to grow any bamboo on any property within the Borough limits unless the Chief of Police or Construction Code Official or member of the Closter Police Department determines, on his or her own or upon complaint from any abutting or nearby property owner, that any portion of such bamboo has been allowed to grow upon, extend roots across, or extend branches, stalks or leaves over any public way or any private property not owned by or in the possession of such land owner, tenant or any possessor of said land.

SECTION 4 Complaint notice; order for removal; compliance.

Whenever a complaint is received by the Borough regarding the encroachment of any bamboo plant or root, or whenever the Borough on its own observation and inspection determines that there is an encroachment of bamboo plants or roots on to the property of another, the Borough, through its delegated official, shall forward a notice of violation to the alleged offending person, property owner, or other in possession of such property (hereinafter the "violator"), which notice shall be substantially as follows:

- A. The notice shall be mailed by certified mail, return receipt requested, properly addressed and with sufficient postage, and also by first-class mail. Notice by certified mail shall be deemed complete on the date of personal delivery, or the date the certified mail is marked refused or unclaimed or otherwise undeliverable by the United States Post Office, when the first-class mail was not returned.
- B. The notice shall specify the nature of the violation.

- C. The notice shall state that the violation must be corrected within 30 days from the date of the received or returned mailing.
- D. The notice shall state specifically what must be done by the violator to correct the violation.

SECTION 5 Violations and penalties.

A. Any person determined by any court of competent jurisdiction to have violated this Ordinance shall be subject to pay a fine of not less than \$25 per day, nor more than \$100 per day, for each day the violation existed after the date for cure as set forth in the notice. Each day of a continuing violation shall constitute a separate offense, for which an additional fine can be levied. The per-day fine will be in addition to a penalty for failure to comply with the Bamboo Ordinance. This fine can be up to the maximum penalty set by the State of New Jersey.

B. If the violation is not remedied within the time set forth in the aforesaid notice, the Borough is hereby authorized to remove or have removed any encroaching bamboo and to take all reasonable steps to eradicate the regrowth of the bamboo on the public rights-of-way, including sidewalks, and to restore such land to its normal condition, prior to such removal and eradication.

C. The cost of the corrective action together with any civil penalties, legal fees and other costs shall be recoverable from the violator or other responsible party.

SECTION 6 Repealer.

All Ordinances of the Borough of Closter which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 7 Severability.

If any sentence, section, clause or other portion of this Ordinance or the application thereof to any person or circumstance shall, for any reason, be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or repeal the remainder of this Ordinance.

SECTION 8 Effective Date.

This Ordinance shall take effect immediately upon final passage and publication as required by law.

BOROUGH OF CLOSTER ORDINANCE NO. 2017:1232 AN ORDINANCE RESTRICTING THE SALE OF DOGS AND CATS FROM PET SHOPS WITHIN THE BOROUGH OF CLOSTER

WHEREAS, a significant number of puppies and kittens sold at pet shops come from largescale, commercial breeding facilities where the health and welfare of the animals are not adequately provided for ("puppy mills" and "kitten mills," respectively). According to The Humane Society of the United States, it is estimated that 10,000 puppy mills produce more than 2,400,000 puppies a year in the United States, and that most pet shop dogs and cats come from puppy mills and kitten mills; and

WHEREAS, the documented abuses endemic to puppy and kitten mills include overbreeding; inbreeding; minimal to non-existent veterinary care; lack of adequate and nutritious food, water and shelter; lack of socialization; lack of adequate space; and lack of adequate exercise; and

WHEREAS, the inhumane conditions in puppy and kitten mill facilities lead to health and behavioral issues in the animals bred in those facilities, which many consumers are unaware of when purchasing animals from pet shops due to both a lack of education on the issue and misleading tactics of pet shops in some cases. These health and behavioral issues, which may not present themselves until some time after the purchase of the animals, can impose exorbitant financial and emotional costs on consumers; and

WHEREAS, current Federal and State regulations do not adequately address the sale of puppy and kitten mill dogs and cats in pet shops; and

WHEREAS, restricting the retail sale of puppies and kittens to only those that are sourced from shelters or rescue organizations is likely to decrease the demand for puppies and kittens bred in puppy and kitten mills, and is likely to increase demand for animals from animal shelters and rescue organizations; and

WHEREAS, according to the data from the New Jersey Department of Health, due in large part to pet overpopulation, more than 20,000 dogs and cats are euthanized in New Jersey animal shelters annually; thus, restricting the retail sale of puppies and kittens to only those that are sourced from animal shelters and rescue organizations will likely reduce pet overpopulation and thus the burden on such agencies and financial costs on local taxpayers; and

WHEREAS, across the country, thousands of independent pet shops as well as large chains operate profitably with a business model focused on the sale of pet services and supplies and not on the sale of dogs and cats. Many of these shops collaborate with local animal shelters and rescue organizations to offer space and support for showcasing adoptable homeless pets on their premises; and

WHEREAS, this Ordinance will not affect a consumer's ability to obtain a dog or cat of his or her choice directly from a breed-specific rescue organization or a shelter, or from a hobby breeder where the consumer can see directly the conditions in which the dogs or cats are bred, or can confer directly with the hobby breeder concerning those conditions; and

WHEREAS, the Mayor and Council believe it is in the best interests of the Borough of Closter to adopt reasonable regulations to reduce costs to the Borough and its residents, protect the citizens of the Borough of Closter who may in the future purchase cats or dogs from a pet shop or other business establishment, help prevent inhumane breeding conditions, promote community awareness of animal welfare, and foster a more humane environment in the Borough; and

WHEREAS, the Ordinance and Legislative Committee has discussed adoption of this ordinance and recommends same to the Governing Body; and

WHEREAS, the Borough Attorney has reviewed this ordinance and deemed it in order; and

WHEREAS, the Governing Body has determined that this ordinance is necessary and in the best interest of the Borough;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Closter, County of Bergen and State of New Jersey, as follows:

Section 1. Definitions.

"Animal care facility" means an animal control center or animal shelter, maintained by or under contract with any state, county, or municipality, whose mission and practice is, in whole, or significant part, the rescue and placement of animals in permanent homes or rescue organizations.

"Animal rescue organization" means any not-for-profit organization which has tax-exempt status under Section 501(c)(3) of the United States Internal Revenue Code, whose mission and practice is, in whole or in significant part, the rescue and placement of animals in permanent homes.

"Cat" means a member of the species of domestic cat, Felis catus. "Dog" means a member of the species of domestic dog, Canis familiaris.

"Offer for sale" means to sell, offer for sale or adoption, advertise for the sale of, barter, auction,

give away or otherwise dispose of a dog or cat.

"Pet shop" means a retail establishment where dogs and cats are sold, exchanged, bartered or offered for sale as pet animals to the general public at retail. Such definition shall not include an animal care facility or animal rescue organization, as defined.

Section 2. Restrictions on the Sale of Animals.

- 1. A pet shop may offer for sale only those dogs and cats that the pet shop has obtained from or displays in cooperation with: (a) An animal care facility; or (b) An animal rescue organization.
- 2. A pet shop shall not offer for sale a dog or cat that is younger than eight (8) weeks old.
- 3. This Ordinance will not affect a consumer's ability to obtain a dog or cat of his or her choice directly from a hobby breeder where the consumer can see directly the conditions in which the dogs or cats are bred, or can confer directly with the hobby breeder concerning those conditions.

Section 3. Severability; Repealer; Effective Date.

If any sentence, section, clause or other portion of this Ordinance or the application thereof to any person or circumstance shall, for any reason, be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or repeal the remainder of this Ordinance. All Ordinances or parts thereof inconsistent herewith are hereby repealed to the extent of such inconsistency. This Ordinance shall take effect immediately upon final passage and publication as required by law.

Resolution Supporting the Advocacy to Widen Bike Paths on the George Washington Bridge

WHEREAS, the George Washington Bridge's sidewalks are the only connection across the Hudson River between New York City and New Jersey for pedestrians, runners and bicyclists; and

WHEREAS, the paths are heavily used, with an average of 1,700 cyclists and 900 pedestrians crossing each day; and

WHEREAS, the sidewalks are ten feet wide except where the bridge's suspender ropes pass through, where they are less than seven feet wide; and

WHEREAS, according to Federal Highway Administration guidelines, shared-used paths should be at least ten feet wide and up to fourteen feet wide if they are heavily used; and

WHEREAS, the Port Authority of New York and New Jersey is planning an extensive renovation that will replace all of the bridge's suspender ropes beginning in 2017 and lasting until 2024; and

WHEREAS, as part of the project, the sidewalks will be repaved and new ramps that will provide access to the sidewalks will be constructed, but the sidewalks will not be widened; and

WHEREAS, the Port Authority's own Bicycle Policy states that its goals are to integrate "improved bicycle access" and "safe bicycle lanes" and to "promote the safe co-existence of motor vehicles, bicycles and bicycle access" and "safe bicycle lanes" and to "promote the safe co-existence of motor vehicles, bicycles and pedestrians" at its facilities; and

WHEREAS, the width of the bridge's sidewalks do not meet federal standards for high-use pedestrian and bicycle paths; and

WHEREAS, the planned renovation project presents a unique opportunity to build sidewalks that would be able to safely and comfortably accommodate the increasing number of pedestrian and bicyclists expected to use the bridge in the decades to come.

In addition, a copy of the notice is and has been available to the public and is on file in the office of the Municipal Clerk.

4. <u>REVIEW AND DISCUSSION OF COMMUNICATION ITEMS</u>

a. <u>MAIL LIST OF OCTOBER 26, 2017</u> – Mayor Glidden asked if any member of the Council wished to address any matter or provide any comments. Item Nos. 6, 7, 10 and 12 were removed by Councilman Barad.

<u>Item No. 6:</u> Received 10/20/17, Dated 10/17/17, from Senator Loretta Weinberg, 37th Legislative District Majority Leader, State Senate re Acknowledging receipt of Resolution expressing opposition to Senate Bills. No. 1045 and 1046 (OPMA and OPRA) with rebuttal points

<u>Item No. 12</u>: Received 10/24/17, Dated 10/20/17, from Senator Loretta Weinberg, 37th Legislative District Majority Leader, State Senate re Follow-up on previous response to Resolution expressing opposition to Senate Bills. No. 1045 and 1046 (OPMA and OPRA) with chart

Councilman Barad informed Item Nos. 6 and 12 were received in response to the Borough's Resolution and he found them to be interesting. If you look at the chart contained in Item 12, she clarifies that the legislation seeks to modify the original ruling; and what we heard from the Municipal Clerk's Association seems different from what she claims in the proposed legislation. Dr. Barad said he hasn't read the old ones or the new ones but recalls one of our concerns as expressed by the Municipal Clerks is that the Bill doesn't protect us from abusive OPRA requests. Senator Weinberg responded that it does in fact have a process for stopping people from people who appear to abuse OPRA. He asked if the Borough Attorney had the opportunity to look at the responses and asked for his thought on the matter. Mr. Rogan advised he did look at it and expressed that it is a work in progress so it's kind of hard to look at it at any point in time. He said there is a provision in there that would allow for taking out a protective order but it's limited to taking action against someone who is excessively filing as opposed to someone who may be asking for an overwhelming response on a one-time or two-time basis. Although it's nice to have that language in there, he isn't sure it's enough to protect municipalities in terms of manpower. You could be hit with one massive OPRA request from someone that takes days to address; and that isn't covered. The Senator expressed in her letter that it is a work in progress so he is hopeful that it be watched by the League and towns such as Closter to keep an eye on and comment on this. It affects the Clerk's office primarily although it could affect each individual Department as well; and it's important to get their input on this as well because they're the ones "in the trenches" so to speak on something like this. Dr. Barad noted other points suggested instead of making copies of things, more documents should be available on the website because

they are public records. Borough Attorney agreed it would be useful and said it's not just the copying that takes up time; it's also the searching which can take hours. We had a request this past week that asked for records going back to 1986. Borough Administrator noted there are organizations that request a blanket amount of items from date A to date B and they are continually doing it. For some reason they are accumulating this information making it available to other persons almost like an ambulance chaser. Dr. Barad agreed we should keep our eyes on it as it is still a work in progress and see how it proceeds. Borough Attorney agreed and explained to Dr. Barad one of the things that has changed since the original proposed legislation was considered was that subcommittee meetings would be open to the public. In his opinion, for a municipality like Closter, that would be a disaster; and we did oppose that proposal at that time; but now they have pulled that back because committee reports on a monthly basis can fulfill that requirement.

Councilwoman Chung entered the meeting at 7:43 p.m.

attorney and the Fair Housing attorney agreed to it. The Borough's COAH Planner is finalizing some of the proposed ordinances in order for us to put together the overall Fair Housing Plan, so that is going along fairly well. Mr. Rogan previously reported our immunity from Builder's Remedy lawsuits has been extended to the end of this year, therefore, he thinks at this point we can get everything done by that time. Because there is an Intervenor in the case, there is still going to have to be a fairness hearing and the Intervenor will have the opportunity to criticize the plan the Borough adopts. He anticipates it will be some time in February because the Planning Board has to review any proposed ordinances which then go to the Mayor and Council for discussion and public comment. Preliminarily the attorney for Fair Housing seems to be satisfied with our plans, but they still need to be looked at in more detail.

2) REPORT – Mr. Rogan reported the DPW negotiations are completed; this morning the Union met and ratified what is proposed; and that is on the Agenda for approval this evening.

He informed the Closter/Rosenblum/Watkins Appeal is still pending and the Supreme Court granted leave to file a brief on his behalf to ask for it and we have opposed that. Normally the court will not grant that type of application but it is pending right now.

In terms of ordinances, Dr. Barad mentioned the Road Improvement ordinance and he voiced his understanding the Executive Summary only went to the committee, so he will forward it to the full Council based upon Dr. Barad's request. It is almost like a "cheat sheet" to the changes being made but the ultimate goal is to increase the fees for road opening permits. On the Ordinance Committee Agenda, which he hopes will be ready for adoption shortly, is an amendment to Chapter 48. It will cap non-contractual employees' vacation time at 4 weeks after 10 years. They were able to work that out with the DPW in this contract; and they will make the change for non-contractual employees via ordinance and address same when the PBA contract expires.

Currently there are 15 Tax Appeals pending for residential and 3 for non-residential. We are still waiting to hear back on the Shared Services Agreement between Haworth, Harrington Park and Closter for Senior Van services in terms of fees. Borough Administrator informed he had an update on same in his report. Mr. Rogan informed his office has been reviewing issues that have arisen with two or three liquor licenses and they are trying to work those out as well.

C. CHIEF OF POLICE

REPORT – Chief Kaine informed he sent the Police Department Monthly Report yesterday. 1) Last weekend there was a large gas main that broke in Harrington Park on Schraalenburgh Road and they evacuated a bunch of residents off Knickerbocker Road by the Exxon station. OEM activated it and the evacuees were taken to the Senior Citizens center for a while and it was hectic for the first night. PSE&G was able to close the main off and the gas dissipated. The event disrupted scheduled milling and paving work.

C. <u>CHIEF OF POLICE</u> (Continued)

The Chief reported that during Thanksgiving weekend there will be mobile and stationary details for DWI patrols which are funded by the Drunk Driving Enforcement Fund. The Department expects delivery of two new vehicles next week so they can start retrofitting them to put them out on the road which should take about two weeks. Chief Kaine reported they will be finishing up Fall qualifications next week including a mandatory active shooter drill with Haworth. They will be using the old Suez building in Harrington Park one day and the Temple on another day. Tomorrow the traffic light at the intersection of Closter Dock Road and Piermont Road will be switched over to the new pattern to allow for the left hand turn arrow and, hopefully, alleviate some of the traffic congestion. He said the light has to be shut off to accomplish this; and urged everyone to avoid that intersection tomorrow; but they hope it will be done by 3 p.m. Chief Kaine reported the Police Trading Cards have started and the rules and information were posted on Facebook.

At this time, the Borough Engineer asked if the contractor for the County contacted the Chief yet about Knickerbocker Road; and he informed he had not as the Schraalenburgh Road project threw everything off. In answer to Councilman Di Dio, he informed the gas main break was due to the age of the pipes and only the section that was open was replaced at this time. Mr. DeNicola noted there has always been a smell of gas in Harrington Park at that intersection; and the Chief said it probably would have broken anyway once they milled the surface.

D. <u>MAYOR</u>

1) REPORT – Mayor Glidden encouraged the League attendees to check out the website as all of the information is on there. He noted the Council was invited to several parties and activities during the Conference.

The Mayor wanted to inform all about several upcoming events: Thursday, 12/7/17, is the tree lighting on the front lawn; and the Menorah will be lit on Tuesday, 12/19/17. The Chamber of Commerce Annual Party is also 12/7/17 at the same time as the tree lighting. On 11/19/17 the Improvement Commission Storytelling contest will be held for the kids and the Mayor was told he is expected to write one.

Mayor Glidden informed he met with the Plaza developer, Edens, last week and he has a few items to report. He hopes everyone noticed the Plaza sign was replaced. They thought it would be improved and cleaned up but when they went to do so, it was corroded and unable to be saved; so they had a new sign made that is an exact replica of the old one. Sometime next week there will be a sign lighting ceremony with a celebration to follow at Rudy's. The Mayor informed that the movie theater is progressing nicely and they anticipate a grand opening to be held on 12/14/17. He said originally he thought it would be later, but they moved the date up because they want to get the first movie in before Christmas and we are working with them to attempt to get the liquor license taken care of. The Chief explained to him last week that there is a problem in that they need to get the fingerprints but the principals live in Mexico. Chief Kaine informed that a meeting has been scheduled with the General Manager tomorrow and Mayor Glidden added that the name of the company is Cinemex. Mayor Glidden said the Plaza indicated they are getting close to renting out the two spots that were going to be Distrito and Village Whiskey, which he previously reported are not coming to the Plaza. They do know there will be two more eateries.

8. <u>OLD BUSINESS</u>

Borough Attorney said he was contacted by the Temple Emanu-El Catering Facility and was advised that both the Ambulance Corps and Fire Department will be holding their holiday parties at the Temple this year which will require permission by the Mayor and Council. He will provide a resolution for the next meeting.

Councilwoman Amitai referred to the potential parking lot for residents going to New York City. She said there is a sidewalk to Third Street and Closter Dock Road and questioned how we should move forward. Borough Engineer said we were going to do a test run to determine utilization before any further improvements such as lighting and paving. Use of the area by only Borough residents would have to be determined; and a meeting should be held to discuss various recommendations so that an announcement can be published in the next newsletter. A sticker system should be discussed and the number regulated to the number of spaces available which should be around 16.

9. <u>NEW BUSINESS</u>

Councilwoman Latner said the High School Play "Almost Maine" will be held in the NVD Auditorium on November 16, 17 and 18 at 7:00 p.m.

Ryan Roy, 167 South Boston Avenue, Saddle Brook Township, 07663 said that he had spoken to Leslie Weatherly and proposed that the Borough of Closter become Stigma Free for Mental Health Awareness. He said there is a handbook for review and there is a list of towns that have been designated stigma free. He is an Advocate for persons with disabilities and making places accessible according to ADA and he provided a sample charter and 501c3 designation information (10. M.L. 11/9/17) and Mayor Glidden asked that Mr. Roy work with Leslie Weatherly on this matter.

Steve Isaacson, 97 Columbus Avenue referred to the need for bus shelters. He also expressed the need for weekly recycling in the Borough. He referred to the clean up of the Herbert Avenue industrial park behind the buildings, which he hoped would be dealt with. In answer to a question on the trail going through the easement, Borough Engineer said there is a portion of private property next to Ruckman Field, which was not incorporated in the easement. Mr. Isaacson referred to the volunteer memorial park, which he hoped would be developed. He referred to the parking lot and said he felt a lottery should be held for parking. He also suggested no overnight parking. He questioned when the Ken's Tree Care Agreement would be coming up for review and Borough Attorney said he would have to review same. Relative to the Menorah Ceremony food, Mr. Isaacson cited the food inspection process, Mayor Glidden advised it would be soft drinks given out by the Rabbi; and Borough Administrator noted that there is a Hold Harmless Agreement and a Certificate of Insurance.

Mike Pisano, 44 Columbus Avenue, advised that the clean up of the Lustron House has started and noted that people are very enthusiastic. He said he read through the Historic Preservation Report, which is detailed. A lot of work has been done; and he questioned if he could let people see the inside of the house. Borough Attorney said the house is insured. Mr. Pisano showed a picture of the car that was at the house which is a1953 Mercury.

Ted L'Strange of Otisville, New York referred to genocide in China and cited cultural taboos in the country. He cited 1984 regulations noting that bodily organs are the property of the state. He passed out a packet to the Council outlining the processes (11. M.L. 11/9/17) and cited documentaries that are being prepared on the subject.
