## RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH BOSWELL ENGINEERING TO PROVIDE ENGINEERING SERVICES FOR THE 2021 IMPROVEMENT OF BOROUGH WATERWAYS IMPACTED BY HURRICANE IDA BOSWELL FILE NO. PR-21-10688

WHEREAS, the Borough of Closter, by resolution dated January 4, 2021, entered into an annual contract with Boswell Engineering for the provision of professional engineering services; and

WHEREAS, the Borough of Closter was impacted negatively by Hurricane Ida along certain streams and waterways; and

WHEREAS, there is a need for cleaning, bank stabilization and de-snagging of the impacted waterways; and

WHEREASadditional professional engineering services are required for the project known as Improvement of Borough Waterways Impacted By Hurricane Ida; and

WHEREAS, the Borough of Closter has requested Boswell Engineering to provide these services in an effort to advance this project; and

WHEREAS, Boswell Engineering has offered to provide the additional, engineering services in a proposal dated December 16, 2021, copy attached, for an amount not to exceed \$247,000.00; and

WHEREAS, N.J.S.A. 40A:11-1 et seq. exempts professional services from certain requirements of public bidding, provided a notice of appointment be printed in a newspaper of general circulation within the municipality; and

WHEREAS, N.J.S.A. 19:44A-20.1 et seq., commonly known as the State "Pay to Play" Law took effect on January 1, 2006 and the Borough had fully complied with the "fair and open" process set forth thereunder; and

WHEREAS, it is deemed to be in the best interests of the Borough for the Mayor and Council to enter into a contract amendment with and thereby authorizing Boswell Engineering to undertake such additional work and responsibility for an amount not to exceed \$247,000.00 for the initial engineering tasks; and

WHEREAS, the Treasurer of the Borough of Closter has (by a Certificate of Availability of Funds) certified, pursuant to N.J.S.A. 40A:9-140.1 et seq. and N.J.A.C. 5:30-5.4, that the funds, which are required by the Borough for the retention of Boswell Engineering, will be available upon the completion of the estoppel period of Borough Ordinance 2021:1287; and;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council that it does hereby approve the execution by the Mayor and Borough Clerk of a contract amendment to the Borough's contract with Boswell Engineering under which Boswell Engineering will provide the additional professional services at an amount not to exceed \$247,000.00; and

BE IT FURTHER RESOLVED that said contract amendment is being awarded without competitive bidding, since the services covered are "professional services," pursuant to N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law, which are services performed by persons authorized by law to practice a recognized profession; and

# RESOLUTION DECLARING ITS NON-ENDORSEMENT OF APPLICATION FOR AWARD OF PERMIT TO OPERATE AN ALTERNATIVE TREATEMENT CENTER FOR NATURE'S TOUCH MED NJ LLC

WHEREAS, the Borough of Closter was advised that the Cannabis Regulatory Commission issued an Award of Dispensary Permit Endorsement to Operate an Alternative Treatment Center ("ATC") Pursuant to the 2019 Request for Application Process to Nature's Touch Med NJ LLC; and,

WHEREAS, the Application submitted by Nature's Touch incorporated a Zoning Permit issued in 2019 which purportedly authorized and approved an application for the sale of medical marijuana for the property located at 273 Closter Dock Road; and,

WHEREAS, as part of the final award of the permit Nature's Touch must provide to the Cannabis Regulatory Commission proof of local approval for the endorsement; and

WHEREAS, the Borough of Closter unequivocally does not support or endorse the issuance of the permit as the Zoning Permit for the property was improperly issued, the issuance of the Zoning Permit was not an action of the Governing Body of the Borough of Closter and did not have municipal support, and the Borough of Closter having thereafter adopted an Opt-Out Ordinance as identified as Ordinance 2021-1279 prohibiting all classes of cannabis businesses as authorized by the Cannabis Regulatory Commission.

### NOW THEREFORE, BE IT AFFIRMED BY THE BOROUGH OF CLOSTER THAT:

- 1. The Borough of Closter does not endorse, support or authorize the issuance of a Permit by the Cannabis Regulatory Commission to Nature's Touch Med NJ LLC for the utilization of the premises at 273 Closter Dock Road as an Alternative Treatment Center.
- 2. The issuance of the 2019 Zoning Permit to Nature's Touch Med NJ LLC has lapsed as is no longer in full force and effect.
- 3. The issuance of the 2019 Zoning Permit to Nature's Touch Med NJ LLC was improper and ultra vires, thereby being null and void.
- 4. The Borough of Closter has subsequently opted out of all six (6) classes of cannabis businesses (Ordinance 2021-1279) as authorized by the Cannabis Regulatory Commission and similarly does not desire or authorize the sale of medical marijuana or issuance of a permit for an ATC within any zone of the Borough of Closter.
- 5. This Resolution shall be sent to the Cannabis Regulatory Commission upon its execution in opposition to the awarding of a Permit to operate an ATC to Nature's Touch Med NJ LLC.
- 6. This Resolution shall take effect immediately.
