7. COMMITTEE REPORTS

- a. <u>FINANCE AND TECHNOLOGY YAMMARINO (DEVLIN/WITKO)</u> A letter was received about Labor Day activities. A resolution will be on the next meeting's agenda. The Coaches' Association wants to change their picnic date from September 2 to September 9. The attorney said that the resolution that was already passed can be amended.
- b. <u>PUBLIC SAFETY LATNER (CHUNG/YAMMARINO)</u> She asked if there was any update on the cutting of the trees suggested by MR. McCaffrey. There is no update.
- c. <u>PUBLIC WORKS CHUNG (AMITAI/WITKO)</u> Residents often have to pay for their own repairs from flood damage. She suggested waiving permitting fees for this work to help them a little and show good faith. The Council felt it was a good idea. She will speak to the Building Department and then talk to the administrator about a resolution.
- d. <u>ORDINANCES DEVLIN (AMITAI/LATNER)</u> The Shade Tree Inventory is underway. Discussion of the benefits of shade trees and the tree map. Election District #2 will be pruned.

- e. <u>HUMAN RESOURCES WITKO (LATNER/YAMMARINO)</u> Councilman Devlin gave the Fire Department report, which showed an increase in incidents and hours. Councilwoman Latner gave The Human Resources report and stated that resumes are being received for an administrative Floater.
- f. <u>LAND USE AND CONSTRUCTION AMITAI (CHUNG/DEVLIN)</u> The CIC is very busy. The International Day may not happen unless someone can come forward to shepherd it. The Welcome Committee met. The Mayor's Committee on the arts has been active. There will be music outside Rudy's at the end of the month (7/30 at 2:00). A volunteer is willing to paint 13 flats (or more) of native NJ wildflowers for the hockey rink at Ruckman. The Recreation Chair has approved the idea. There are two possible murals in the works. Linda Albelli is working hard to create activities for the Seniors.
- g. <u>MAYOR'S LIAISON REPORT</u> Ellen Lutvak and Mike Pisano will do a pottery demonstration in front of Ma Mere on 8/4 at 5:00 pm. The Mayor has been asked to write an article about Closter and sent an email to the Council for suggestions. The Ambulance Corps has been busy.

8. OLD BUSINESS

- 9. <u>NEW BUSINESS</u> Councilwoman Chung attended the insurance seminar today and learned a lot. She asked for a moment of silence, which will be done at the beginning of the regular meeting.
- OPEN FOR PUBLIC COMMENTS (5-MINUTE LIMIT) Steve Isaacson said that trees on his property that 10. are not shade trees are showing up on the application. He suggested getting someone to cut the trees that had been discussed with John McCaffrey. He also asked why committees were eliminated from the improvement commission and followed up on his statement last meeting that fees are being paid directly to the coaches' association. The attorney had reviewed this with the administrator and Recreation Commission. Discussion. Elise Vazquez Iscan, 45 High Street, said that there is an issue with vandalism (and was told this by employees at CMX and Target and also at the middle school). She spoke about the importance of good relations with the local businesses. The Mayor and Councilwoman Latner spoke on the issue. It may be that not all incidents are being reported. If incidents increase, the management company may be asked to supply private security (as discussed before the Plaza was built). Councilwoman Amitai felt that security was supposed to be supplied by the management committee from the beginning. The administrator said that the issues seem to be more rowdy misbehavior a lot of the time than vandalism that would involve the police. Julie Brueck (27 John Street) stated that she and her husband sent emails to everyone on July 20 and has not heard back. She explained her issue of not receiving her dog license despite being brought into court for erroneous late fees. The administrator said that the late fees needed to be paid before the license could be paid. Ms. Brueck feels that she paid the fees. The Board of Health is an autonomous body, but the Mayor said they would look into this. There have been several complaints with the pet licensing system. Councilwoman Chung said this is on the agenda for the Board of Health meeting in September. She will send Ms. Brueck a link.
