RESOLUTION EXPRESSING SUPPORT FOR S-3906 WHICH WOULD PROVIDE THE BOROUGH OF CLOSTER WITH \$2,775,541.75 OF STATE FUNDS TO REPAY DEBT, ADVANCE CAPITAL PROJECTS AND PROVIDE PROPERTY TAX RELIEF

WHEREAS, the New Jersey Debt Defeasance and Prevention Fund was created for the purpose of repaying or defeasing taxpayer-funded debt and funding capital projects that would otherwise be paid for with new debt; and

WHEREAS, the New Jersey Debt Defeasance and Prevention Fund is expected to have an unallocated balance of at least \$4.32 billion; and

WHEREAS, members of the New Jersey Senate Republican caucus, including Senator Holly Schepisi have introduced Senate Bill 3906 (S-3906), which would allocate \$4.32 billion from the New Jersey Debt Defeasance and Prevention Fund to towns and counties to repay local government debt, advance capital projects of their choosing, and provide property tax relief to residents; and

WHEREAS, funds would be allocated by S-3906 on a per capita basis, meaning every town and county would get a fair share of funding based on population; and

WHEREAS, S-3906 provides that \$3 billion would be allocated to New Jersey municipalities on a per capita basis, and \$1.32 billion would be allocated to New Jersey counties on a per capita basis; and

WHEREAS, prior allocations from the New Jersey Debt Defeasance and Prevention fund have not been determined in a fair, equitable, or transparent manner; and

WHEREAS, the Borough of Closter would receive an estimated allocation of \$ 2,775,542.76 under S-3906 based on 2020 United States Census data; and

WHEREAS, S-3906 requires funds to be disbursed within 30 days of the legislation's enactment; and

WHEREAS, S-3906 is not expected to have a fiscal impact on the proposed State Budget for Fiscal Year 2024; and

WHEREAS, local and county governments are contending with soaring health care premiums, rising pension costs, and inflationary pressures that have impacted their budgets; and

WHEREAS, the significant allocations to towns and counties across New Jersey that have been proposed under S-3906 would help to lower and stabilize property taxes for years to come.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body that the Borough of Closter supports Senate Bill 3906, "Give It Back" property Tax relief; and

NOW, BE IT FUTHER RESOLVED, the Borough Clerk is requested to send a signed resolution to Senator Holly Schepisi.

Boswell Engineering (Boswell) is pleased to submit this proposal for the engineering and environmental permitting services associated with the above referenced project.

Boswell Engineering performed a site inspection following the aftermath of Tropical Storm Ida, and found six (6) areas of concern, namely:

Tenakill Brook Tributary:

- Sediment removal under and within ±50 linear feet up and down stream of the Durie Avenue culvert.
- Sediment removal and bank stabilization along ±600 linear feet of stream from Block 609 Lot 2 to Block 1002 Lot 8 (including Julia Street Culvert) and reinstallation of pedestrian bridge on Brook Street.
- 3. Drainage improvements along Birch Street and Haring Street, including adding additional drainage structures and replacing an existing stormwater outfall.

Anderson Brook:

- 1. Sediment removal and bank stabilization along ±914 linear feet of stream from Block 1605 Lot 17 to Block 1703 Lot 2 (including Homans Avenue).
- 2. Sediment Removal and bank stabilization along ±1,140 linear feet of stream from Block 2306 Lot 16 to Lot 42 (near Meadows Lane).

Dwars Kill Tributary:

 Sediment removal and bank stabilization along ±1,280 linear feet of stream from Block 2006 Lot 6 to Block 2102 Lot 22 and replace a ±200 linear foot retaining wall. The Honorable Mayor and Council Borough of Closter October 1, 2021 Page 2 of 6

All three (3) watercourses have a drainage area over 50 acres, and carry a surface water classification on FW2-NTC1. Therefore, New Jersey Department of Environmental Protection (NJDEP) permitting is required. Sometimes, hard treatments, such as boulders and gabions are used to stabilize banks because stream velocities are exceeded for vegetative or bioengineering stabilization methods. However, the New Jersey Department of Environmental Protection (NJDEP) discourages the installation of hard treatments on a regulated watercourse without proper engineering justification. Once the bank is stabilized the area must be restored with native vegetation to re-establish the riparian buffer associated with the disturbance.

To minimize NJDEP permitting and construction costs, all items are proposed to be performed under one project and NJDEP permit. Due to the preliminary nature of the project, estimated construction costs will vary depending on the required extent of the improvements and the total quantity of materials. However, Boswell anticipates the construction costs to be as follows:

 Sediment Removal:
 \$ 80,000 - \$ 160,000

 Retaining Wall:
 \$250,000 - \$ 350,000

 Bank Stabilization:
 \$500,000 - \$ 700,000

 Reinstall Pedestrian Bridge:
 \$ 30,000 - \$ 50,000

 Drainage Improvements:
 \$ 75,000 - \$ 100,000

Total: \$935,000 - \$1,360,000

Boswell will prepare the required permit applications, as well as construction plans and specifications necessary for the bank stabilization.

SCOPE OF WORK

Services to be provided by Boswell in order to complete the above referenced project include the following:

Pursuant to the NJDEP regulations, a Flood Hazard Area Individual Permit and Freshwater Wetlands General Permit No. 20 and General Permit No. 25 will be required for the proposed disturbances to the riparian zone and watercourse associated with the sediment removal, bank stabilization, drainage improvements, and retaining wall repair. The scope of work will include the preparation and submission of the environmental and engineering plans and permit applications.

The following is a list of tasks which Boswell will perform during the permit application and construction inspection process:

Task No. 1 - Field Survey

Boswell Engineering will survey the area within the project limits as follows:

- Locate top and bottom of stream bank;
- Survey stream cross-sections at various locations as required by Flood Hazard Control Act Regulation;
- Locate top and bottom of bank along the specified project area;
- Topography within 25' top of bank;

- Elevations along the top and bottom of slope;
- Existing centerline of the tributary; and,
- Any trees located within the work area.

As part of this task, Boswell will also post-process all data and provide a base map in NAVD 1988 Datum. This base map will be used to create constructions plans for the proposed bank restoration.

The estimated fee does not include additional field surveying and topographic information other than that described under this task. If additional surveying is requested by the NJDEP there will be an extra cost.

Our estimated fee for the work associated with Task No. 1 is \$22,000.00.

Task No. 2 - Plan Preparation

Boswell will prepare all necessary Civil Engineering Site Plans and Environmental Permitting Plans required for the various permit application requirements to include:

- · Quantification of regulatory disturbances;
- Limit of existing wetland/upland boundary and riparian zone;
- Existing and proposed Flood Hazard Area and floodway;
- All proposed improvements;
- Stream cross sections;
- Proposed grading;
- Proposed planting schedules; and,
- · Bank restoration details.

Our estimated fee for the work associated with Task No. 2 is \$35,000.00.

Task No. 3 - Hydrologic Analysis, Drainage Design

Boswell will evaluate existing and proposed drainage patterns along Birch Street and Haring Street. These delineations will be used to determine the amount of runoff the proposed drainage system must accommodate, and ensure no change in downstream drainage. These calculations will then be used to determine the appropriate pipe size, slope, and structure depth to ensure that the roadway will drain properly.

Our estimated fee for the work associated with Task No. 3 is \$10,000.00.

Task No. 4 - NJDEP Permit Preparation

Boswell will complete a Flood Hazard Area Individual Permit and Freshwater Wetland General Permit No. 11, 20, and 25 application packages for submission to the NJDEP. The permit applications will include the following:

- Applications, including Land Use Regulation Program Form (DLUR);
- Freshwater Wetlands General Permit Administrative Checklists;
- Existing site photographs of the project area;
- Copy of the necessary location maps and figures;

- Notices to adjacent property owners, certified mail, return receipt requested (mailing costs to be paid by Borough);
- · Wetland Delineation (as required);
- Environmental Report as per N.J.A.C. 7:13;
- Compliance Statement as per N.J.A.C. 7:7A;
- · Natural Heritage Database Results; and,
- NJDEP application fees (to be paid for by the Borough approximately \$7,000.00*).
- * Permit fee assumes that all work areas will be designed and permitted as one project, with one universal NJDEP permit approval.

Our estimated fee for the work associated with Task No. 4 is \$15,000.00.

Task No. 5 - Structural Design

Under Task No. 5, Boswell will design approximately 200 linear feet of retaining wall, pedestrian bridge footings, and concrete headwall as well as prepare plans, details and specifications for all designed items. A geotechnical investigation and preparation of a foundation report will be performed to establish the foundation design criteria for the wall, as well as for the proposed addition. A series of test pits will also be performed as part of the geotechnical exploration to determine the location of the wall/stair footing in the vicinity of the proposed addition. This investigation will be conducted by our Geotechnical Consultant.

Our estimated fee for the work associated with Task No. 5 is \$35,000.00.

Task No. 6 - Soil Erosion and Sediment Control Compliance

Under Task No. 6, Boswell will complete an application to the Bergen County Soil Conservation District (BCSCD) and a NJDEP Authorization to Discharge (Construction Activity Stormwater General Permit) from the State of New Jersey. The Authorization to discharge is necessary for any activity that creates over 1-acre of total land disturbance. This task includes the following:

- Application preparation;
- Soil Erosion and Sediment Control Plans with limit of disturbance and proposed soil erosion measures;
- Details including general notes, limits of disturbance, estimated construction sequence and stabilization procedures; and,
- Application fees (to be paid for by the Borough, which are dependent upon area of disturbance). We anticipate a fee of \$1,725.00.

Our estimated fee for the work associated with Task No. 6 is \$2,500.00.

Task No. 7 - NJDEP and BCSCD Coordination

Following the application's submission, we will monitor the progress of the permits and attend up to one (1) field visit to the project site with the NJDEP and/or BCSCD.

The completion of the application is dependent on the receipt of several items noted within the proposal. Naturally, we will remain in contact with the NJDEP and BCSCD review staff in an effort to expedite scheduling of the site inspection and issuance of the permits.

Our estimated fee for the work associated with Task No. 7 is \$5,000.00.

Task No. 8 - Bid Services

Boswell will prepare construction plans and bid specifications suitable for public bidding in a form and manner that will meet with all State and Federal requirements. The final contract document will include the following:

- Construction plans;
- Borough contract documents with boilerplate;
- Advertisement of Bids;
- Instruction to Bidders;
- General Conditions of the Contract;
- Scope of Work; and,
- Technical Specifications.

Our office will perform the following services during the bidding phase:

- Answer questions from prospective bidders;
- Issue Addenda, as required;
- Analyze Bids; and.
- Provide Letter of Recommendation of Award to the Borough.

Our estimated fee for the work associated with Task 8 is \$7,500.00.

Task No. 9 - Construction Inspection

Following the award of the contract, we will coordinate and attend a pre-construction meeting with the contractor, appropriate Borough officials and other interested parties. We will also review the permit documents with the contractor so that they are familiar with the regulatory requirements of the site's environmentally sensitive areas.

Once work commences, Boswell will provide part-time environmental oversight and construction inspection. We will ensure that the contractor is in compliance with the design plans and specifications. Additionally, we will review submittals and contractor invoices and prepare the necessary Estimate Certificates for Borough approval.

This task assumes the entire project is bid at one time and not segregated into multiple phases.

Our estimated fee for the work associated with Task 9 is \$60,000.00.
