**FALL 2019 Shade Tree Commission**  
**TREE PLANTING QUOTE**

July 17, 2019

The Closter Shade Tree Commission is requesting quotes for the **2019 Fall tree planting**.

- a. **Trees are to be of two (2") to two and one half (2-1/2") inch caliper; single stem, balled & burlapped**
- b. **Wire baskets** must be removed during planting
- c. All trees will be planted and finished with a **minimum 3" layer of hard wood or bark mulch**; *no mulch "volcanoes" around tree base, only "donuts"*
- d. Trees are to be planted in accordance with **A.N.S.I.** specs
- e. Trees are to be staked *only* when necessary
- f. Root flare must be 1" above surrounding grade
- g. Planting must occur in **October 15<sup>th</sup> – November 15, 2019.**
- h. **Planting must be completed by November 15, 2019.**
- i. **Contractor is responsible for securing utility mark-outs prior to planting**
- j. Deer guards must be provided and placed on each tree (A.M. Leonard BG48 Rigid Mesh 48")  
White paper tree wrap to be installed on Maples in addition to deer guards.
- k. Trees must be sourced and grown within 300 miles of Closter, New Jersey
- l. ***Substitutions will not be accepted without prior, written approval*** of the Shade Tree Commission
- m. Trees are to be guaranteed for a period of one year from the date of job completion

**Street Trees: Price for total quantity of 48 of the following species must be submitted on the attached sheet. All trees must be a minimum 2 - 2½ inch caliper.**

**Written quotes must be received by 11:00 a.m. on Friday, August 23, 2019 in a sealed envelope clearly marked "Tree Planting"** - Shade Tree Commission, Attn: Leslie Weatherly, Borough of Closter, 295 Closter Dock Road, Closter, New Jersey 07624.

A NJ Business Registration Certificate, Signed W-9, current Certificate of Insurance, listing the “Borough of Closter as additional insured” and signed Hold Harmless Agreement (if one is not currently on file with the Borough) must be provided pending the award of the job. Samples are attached. The Borough reserves the right to edit, change, add or remove trees as needed.

**PLANTING:**

\* Trees are to be of two (2) to two and one half (2 ½) inch caliper, single stem, balled & burlapped.

\*\* Trees are to be planted within the Borough of Closter locations designated by the Borough through its Shade Tree Commission. Trees are to be handled with care; unloaded *not* dropped. Trees must be planted according to NJ Forestry standards. Root flare to be 1” above grade. Trees will be staked when necessary and mulched with 3” of hardwood or bark mulch; deer guards. Trees must be watered at time of planting. Basket or burlap is to be cut and removed at time of planting. Adventitious roots above root flare to be removed at time of planting. *Contractor* is responsible for notifying utility companies *prior* to planting to insure all utilities are marked accordingly. Planting must be complete by November 15, 2019.
