Sealed bids will be received by the Borough of Closter, Mayor and Council, at the Closter Borough Hall, 295 Closter Dock Road, Closter, New Jersey 07624 in the County of Bergen and State of New Jersey on March 16, 2022 at 11:30 a.m. prevailing time, and then publicly opened and read aloud for:

# IMPROVEMENTS TO MACARTHUR AVENUE & ARNOLD AVENUE, IMPROVEMENTS TO RAILROAD AVENUE, AND 2022 ROAD PROGRAM BOROUGH OF CLOSTER BERGEN COUNTY, NEW JERSEY

The work to be performed under this contract includes the following:

#### Base Bid 1 – 2022 Municipal Aid:

Milling and resurfacing of MacArthur Avenue (Homans Avenue to Arnold Avenue) and Arnold Avenue (Wainwright Avenue to Alpine Drive) including replacement/installation of curbs, sidewalks, ADA curb ramps, reconstructed manholes, and other incidentals.

#### Base Bid 2 – 2021 Local Freight Impact Fund:

Milling and resurfacing of Railroad Avenue (Naugle Street to Van Sciver Street), including replacement/installation of curbs, sidewalks, driveways, inlets, pipes, reconstructed manholes and inlets, RPMs, and other incidentals. The project also includes the removal of existing railroad tracks on Railroad Avenue.

#### Base Bid 3 – 2022 Road Program:

Milling and resurfacing of various streets within the Borough as provided for on the contract plans, including replacement/installation of curbs, sidewalks, pipes, ADA curb ramps, reconstructed manholes and inlets, and other incidentals. The project also includes the replacement of an existing 24" CMP with new 24" RCP at the Closter Nature Center (154 Ruckman Road).

#### Alternate Bid – 2022 Road Program:

Sealing of cracks in hot mix asphalt surface course on various streets throughout the Borough of Closter.

Principal items of work in the project include:

- 1,565 TON Hot Mix Asphalt 9.5M64 Surface Course

  - 1,095 TON Hot Mix Asphalt 12.5M64 Surface Course
  - 1,755 L.F. 9" x 18" Concrete Vertical Curb

### Base Bid 3 – 2022 Road Program:

- 8,070 S.Y. HMA Milling, 3" or Less
- 860 TON Hot Mix Asphalt 9.5M64 Surface Course
- 325 TON Hot Mix Asphalt 12.5M64 Surface Course

#### Alternate Bid – 2022 Road Program:

25,000 L.F. Sealing of Cracks in Hot Mix Asphalt Surface Course.

The work contemplated under this Contract shall be completed within 75 days of notice to proceed.

Copies of plans, specification, and contract documents will be on file for public inspection and may be obtained upon payment of \$73.00, said sum not refundable, at Boswell Engineering, 330 Phillips Avenue, South Hackensack, New Jersey 07606, between the hours of 9:00 a.m. and 4:00 p.m. prevailing time, Monday through Friday, excluding legal holidays.

Each bid must be made upon the prescribed forms, furnished with the Contract Drawings and Specifications, including the non-collusion affidavit and ownership statement compliance form and must be accompanied by a Consent of Surety and a certified check, cashier's check, or Bid Bond of not less than ten (10%) percent of the amount bid and, not to exceed \$20,000.00. Such checks and Bonds shall be made payable to the Owner and will be held as a Guarantee that in the event the Bid is accepted and a Contract awarded to the bidder, the Contract shall be duly executed and its performance properly secured. The successful bidder shall furnish and deliver to the Owner a performance and payment bond in the amount of 100 percent of the accepted bid amount as security for the faithful performance and payment of the Contract. Further, the successful bidder must furnish the policies or Certificates of Insurance required by the Contract. In default thereof, said checks and the amount represented thereby will be forfeited to the aforesaid Owner as liquidated damages. Bids must be accompanied, in the case of corporations not chartered in New Jersey, by proper certificate that such corporation is authorized to do business in the State of New Jersey.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 regarding equal employment opportunity, as amended. All corporations and partnerships must comply with Chapter 33, of the P.L. of 1977, regarding disclosure of partners and stockholders. Each bid must be enclosed in a sealed envelope bearing the name and address of the bidder, addressed to the Owner and labeled for the IMPROVEMENTS TO MACARTHUR AVENUE & ARNOLD AVENUE, IMPROVEMENTS TO RAILROAD AVENUE, AND 2022 ROAD PROGRAM.

The successful bidder will be required to comply with all provisions of prevailing wage rates as determined by the New Jersey Department of Labor.

All bids shall be irrevocable, not subject to withdrawal and shall stand available for a period of sixty (60) days.

The Owner reserves the right to reject any and all bids, to waive informalities or irregularities in the bids received and to accept the bid from the lowest responsible bidder.
